Ambassador Alfred Leroy Atherton, Jr., served as Executive Director, Una Chapman Cox Foundation in Washington, DC until 1998. Ambassador Atherton is also the Senior Advisor to the Director of Harkness Fellowship of the Commonwealth Fund of New York. Ambassador Atherton's distinguished career with the Foreign Service included posts as Ambassador to Egypt, Ambassador at Large for Middle East Negotiation, and Assistant Secretary of State for the Near East and South Asia. He also authored articles on Middle East subjects which have appeared in *Foreign Policy*, *The New York Times*, *The Washington Post*, *The International Herald Tribune*, as well as other journals and newspapers. Ambassador Atherton is also the author of "Egypt and US Interests" a Policy Brief, published by the Foreign Policy Institute of the School of Advanced International Studies of The Johns Hopkins University. He received both his BS and MA from Harvard University. Ambassador Atherton is the recipient of Superior and Distinguished Federal Civilian Service Award, and The National Civil Service Award.

Betty Wylie Atherton, previously taught in Damascus International School, Potomac School, National Cathedral School for Girls and Lab School of Washington in Washington, DC. Kiesha Haughton is an Assistant to Professor Thomas Rowe, Director of ICAP. She recently completed her MA degree at the Graduate School of International Studies, University of Denver. Her work experience includes interning for the National Summit on Africa and working for VISA International. Ms Haughton received the Dorothy Danforth Compton Fellowship, the Social Science Fund Scholarship, and the Foreign Language Abroad Scholarship (FLAS), while she pursued her MA from the University of Denver. Her Master's degree, in Global Finance, Trade and Economic Integration with a certificate in International Development, led her to focus on the economic development of developing countries and write her thesis on Debt Relief. Ambassador William H. Itoh, is currently Ambassador in Residence at the Kenan Institute of the University of North Carolina. He previously served as Executive Secretary of the Overseas Presence Advisory Panel which presented its recommendations on the composition, location and staffing of American Embassies abroad to the Secretary of State in November 1999. From 1996-1999 he served as Ambassador to the Kingdom of Thailand. Prior to his appointment to Bangkok, Ambassador Itoh served as Executive Secretary of the National Security Council at the White House from 1993-1995. A career member of the Senior Foreign Service, Ambassador Itoh has held a number of positions in the Department of State and abroad. His overseas tours have included assignments as the US Consul General to Western Australia in Perth (1986-1990) and as a Consular and Political Officer in the US Embassy in London (1976-1978). His Washington assignments have included the Office of Under Secretary for Political Affairs, the Bureau of East Asian and Pacific Affairs, and the Bureau of Congressional Relations. He also served as Deputy Executive Secretary and Acting Executive Secretary of the Department of State, 1991-1993. Ambassador Itoh attended the University of New Mexico and received a BA in Social Science and an MA in History and Anthropology. He has also been a secondary school teacher in the Albuquerque public schools, an Assistant Professor of History at California State University in Humboldt, California, and a former Air Force officer.

Brioni James, came to Peace Corps Headquarters after working as a Foundation Representative for the Inter-American Foundation. Prior to that position, she worked as a Hotel Manager for the Department of Defense and a Professor for both the Panama Canal College and the University of Santa Maria la Antigua. During his career, he has held positions as Director General of the Foreign Service, and held positions in the Bureau of Personnel, Bureau of Far Eastern and South Asian Affairs and Office of Management Operations. He has served in the US Embassy in Accra, Ghana (1978), and as deputy Chief of Missions to the US Embassy in Monrovia, Liberia (1981). Leonard H. Robinson, Jr. is President and Chief Executive Officer of the National Summit of Africa. He has more than 30 years working and living experience in international affairs, with Africa and Asia as regions of specialization. Mr. Robinson served as Deputy Assistant Secretary of State for African Affairs, from 1983-85, where he was responsible for economic and commercial policy. And, as Deputy Assistant Secretary of State from 1990-1993, he was responsible for U.S. policy toward Central and West Africa. His other portfolio for Africa included Narcotics, Terrorism, Democracy and the Peace Corps. He also directed U.S. diplomatic initiatives to help in the resolution of the Liberian civil war. Mr. Robinson spent six years as President of the U.S. African Development Foundation, established by congress in 1981 to provide official assistance to community-based organizations and grassroots enterprises throughout Africa. He has also worked with the U.S. Agency for International Development, the Battelle Memorial Institute, and Peace Corps where he served as a volunteer, Associate Director for India and as Director of Minority Recruitment for the United States. Mr. Robinson received his B.A. from Ohio State University. He attended graduate school at the State University of New York, Binghamton, and post graduate School at the American University, Washington, D.C. and Harvard's John F. Kennedy School of Government. He is the recipient of two honorary doctoral degrees.

In 1984, he served in Naples, Italy as a Political, Economic,

Commercial Officer and in 1986 became Executive Assistant to the US Ambassador in Rome. In 1988, he served as Deputy Director for Central American Affairs and worked as an observer to peace talks between the Salvadoran government and the FMLN. In 1991, he was assigned as Deputy Chief of Mission/Charge d'Affairs to the US Embassy in El Salvador. From 1993 to 1996 he served as Ambassador to Ecuador. Ambassador Romero has received several Superior Honor Awards including the prestigious Baker-Wilkins award for leadership and management.

E. Thomas Rowe is Director of ICAP, Associate Professor and former Dean of the Graduate School of International Studies at the University of Denver. He received his Ph.D. from the University of California, Berkeley, and previously served on the faculty at the University of Connecticut and Virginia Polytechnic and State University. Professor Rowe has been a visiting professor at the University of Colorado, Boulder, and the University of Tübingen, Germany. He has received grants from numerous foundations and government agencies and lectured in the United States, Costa Rica, Ghana, and Europe. Justice Gregory Kellam Scott, currently serves as chief legal officer of Kaiser-Hill Company, LLC providing counsel and legal advice to the President and CEO and directing the legal department. Justice Scott serves on the National Board of the Constituency for Africa.

She is the former Vice President for Public Policy and External Affairs for InterAction, a coalition of more than 160 US-based non-profits working to promote human dignity and development in 165 countries around the world. Ernest Wilson, III, is Director, Center for International Development and Conflict Management at the University of Maryland. Professor Wilson has been deeply involved in international affairs for many years, combining scholarship and writing with applied programs and projects in Africa, Eastern Europe, and Latin America.
